Check: Weekly Cycle - Commissions close out Friday, check mailed the following Tuesday

American General

EFT: Weekly Cycle - Closes on 5 pm CST Friday, commissions generated Tuesday
Check: Bi-weekly Cycle - Closes at 5 pm CST on Friday, check mailed the following Wednesday

American National

Weekly Cycle - Closes on Friday, commissions generated the following Tuesday

Aviva

EFT (Life): Weekly Cycle - Closes on Thursday, commissions generated the following Tuesday
EFT (Annuity): Daily Cycle - Commission released within 48-hrs of policy being released
Check (Life & Annuity): Monthly Cycle - Processed the last business day of the month, released the following business day

Genworth

EFT: Weekly - Closes on Wednesday, commissions generated on Saturday and deposited on Monday

ING ReliaStar

EFT: Weekly – Closes on Friday, commissions generated on Monday and deposited on Tuesday
Check: All policies placed inforce each month will pay the first week of the following month

ING USA

EFT: Daily Cycle - Commissions released within 48-72 business hours of policy being released

Weekly Cycle - Closes at 12 pm Thursday, commissions generated on Friday

Liberty Mutual

Weekly Cycle - Closes at 7:30 pm CST on Thursday, commissions generated on Friday

Weekly - Closes on Wednesday, commissions generated the following Monday

MetLife

EFT: Weekly Cycle – closes on Thursday, commissions generated the following Wednesday
Check: Quarterly – close the last day of month, commission check released in the first week of the following month

New York Life

Weekly Cycle - closes on Friday, commissions generated the following Monday

North American (Annuity) / Midland National (Annuity)

EFT (required): Daily Cycle - Commissions released within 48-hours of policy being released

North American (Life)

EFT (required): Weekly Cycle - closes at 12:30 pm CST Friday, commissions generated the following Tuesday
Also runs a special comp run on the last business day of every month

Pacific Life

Bi-Monthly Cycle - Closing dates generally the 15th and last business day of the month
Pay Date: EFT ONLY - Comp generally released on 4th and 22th

Reliance Standard

Bi-weekly Cycle - closes at 3:00 pm EST Tuesday and Thursday of every week, to pay out every Wednesday and Friday

Standard

Bi-weekly Cycle - Closes two business days prior to payday, at close of business to pay out on the 15th and the last business day of the month.

EFT: is released the evening before payday, checks are sent out on payday

West Coast Life

EFT: Weekly Cycle - closes at 3 pm on Friday, commissions generated the following Monday
Check: Monthly Cycle - all policies placed inforce each month will pay the first week of the following month
